Genoa Township awarded DNR Grant

Genoa Charter Township has received a Department of Natural Resources Trust Fund grant in the amount of \$300,000 for the acquisition of 88 acres adjacent to the Township Park on Dorr Road. This brings the total acreage owned by the Township adjacent to the Township Hall to 158 acres. We will be seeking public input on the future land use for active and passive recreation on this property. Revenue derived from oil, gas, and mineral production from state-owned lands provides funding for this grant.
