### Genoa Township Capital Improvements Plan - 2022-2027

The Township's fiscal year begins April 1<sup>st</sup>. Every year the Township Board identifies projects to improve the community. The projects fall into the categories of: Parks and Paths, Roads, Buildings and Grounds and General Fund Capital Outlay. This year's CIP identifies \$3.8M in projects, mostly on roads, with the paving and repaving of Crooked Lake Road from Dorr to Latson the largest single expenditure.
