Please be advised that the Planning Commission meeting scheduled for 6:30pm on Monday, September 11, 2023 at Three Fires Elementary School has been CANCELLED. The applicant for the S. Latson PUD Expansion project has requested to postpone their request to a future meeting date in October. Since this was the only agenda item on the September 11, 2023 meeting, the meeting has been cancelled.

The public hearing for this case will be re-scheduled to a pending date and location in October. In accordance with State Law, written notice will be published and delivered at least 15 days before the meeting confirming the details of the rescheduled hearing.
