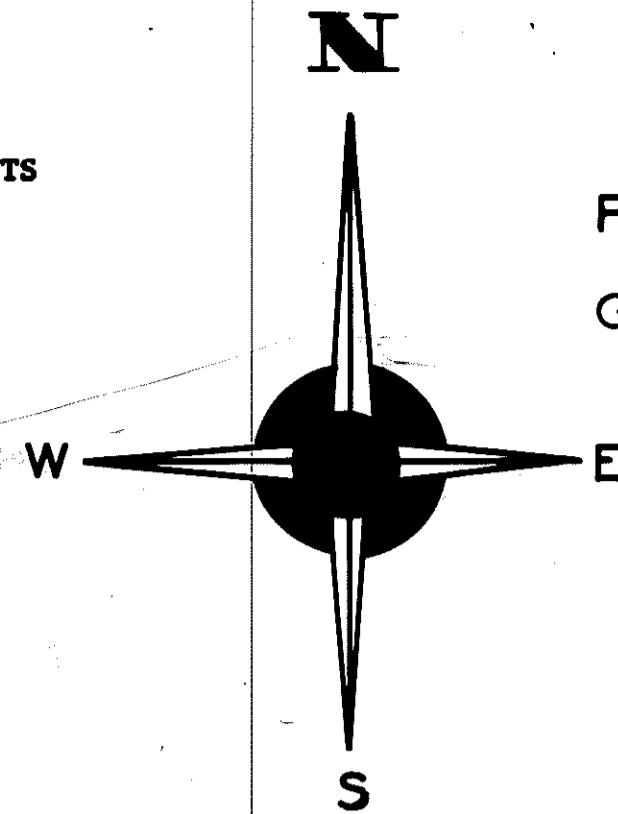


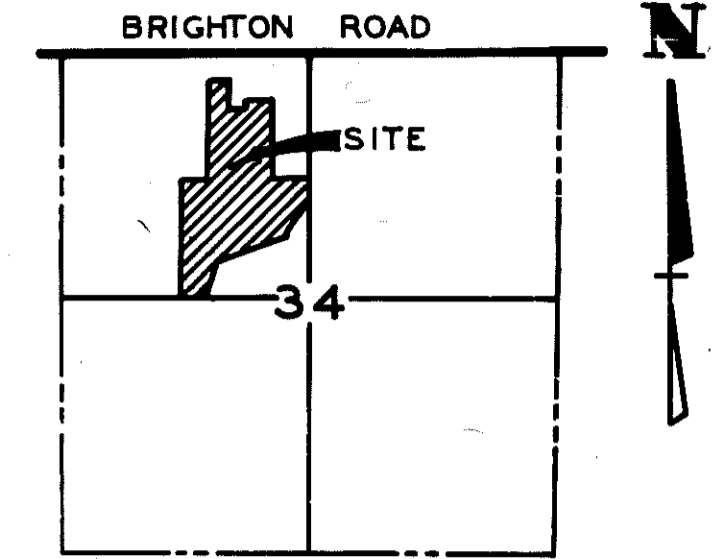

SURVEYOR'S CERTIFICATE:

I, David C. Finney, Surveyor, certify: That I have surveyed, divided and mapped the land shown on this plat, described as follows:

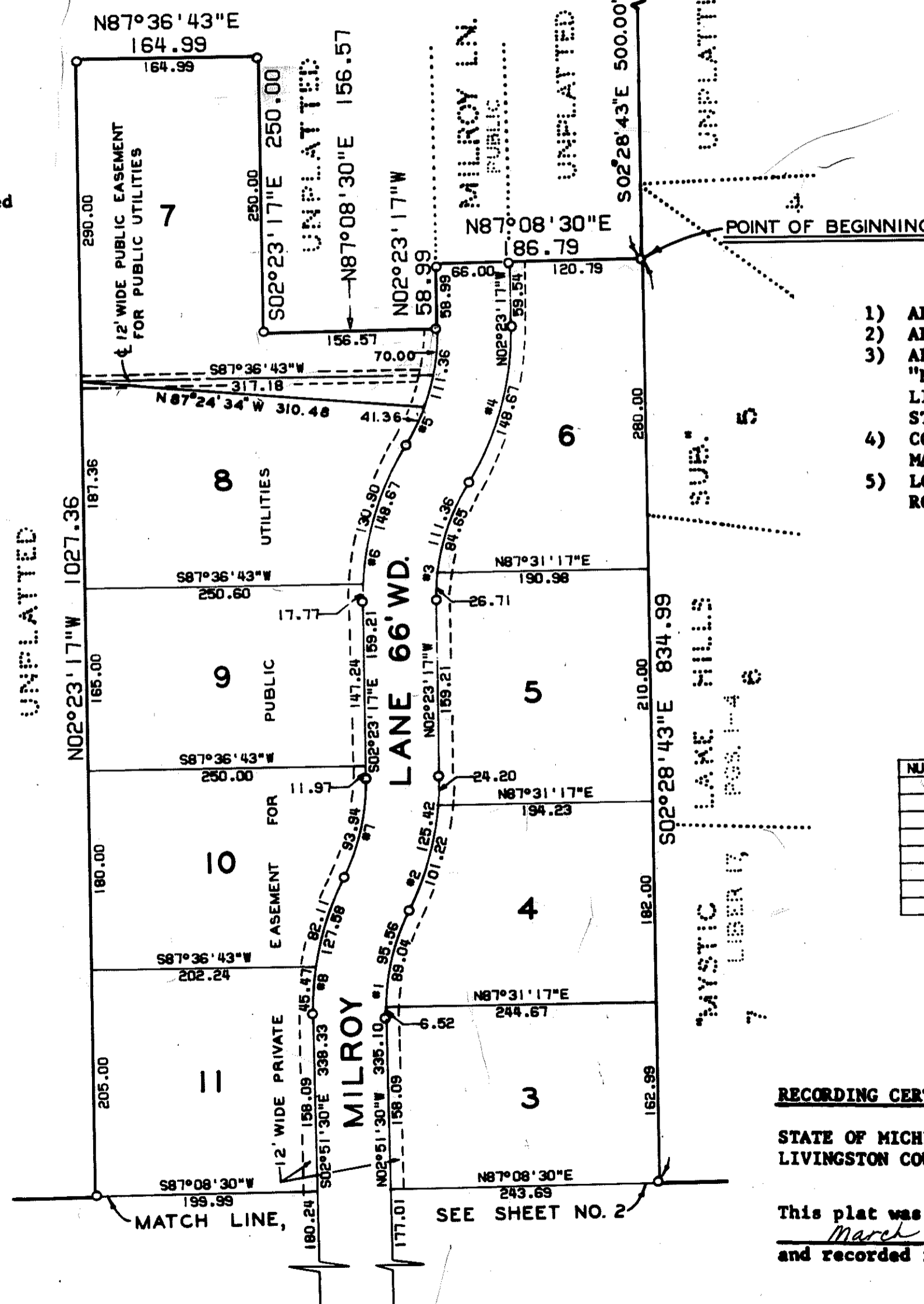
"MYSTIC CREEK", A subdivision of part of the N.W. 1/4 of Section 34, T. 2 N., R. 5 E., Genoa Township, Livingston County, Michigan, described as commencing at the North 1/4 corner of said Section 34; thence S. 87° 08' 30" W., along the North line of said Section 34, 482.00 ft.; thence S. 02° 28' 43" E., 500.00 ft. to the point of beginning; thence continuing S. 02° 28' 43" E., along the West-erly line of "MYSTIC LAKE HILLS SUBDIVISION", as recorded in Liber 17 of Plats, pages 1 through 4, inclusive, Livingston County Records, 834.99 ft.; thence N. 87° 08' 30" E., along the Southerly line of said subdivision 196.00 ft.; thence N. 02° 21' 52" W., 198.28 ft.; thence along a non-tangent curve to the left, radius of 75.00 ft., through a central angle of 52° 12' 28", chord bearing N. 87° 38' 11" E., 66.00 ft., an arc distance of 68.34 ft.; thence S. 02° 21' 52" E., 197.71 ft. to the Southerly line of said subdivision; thence N. 87° 08' 30" E., along said line, 220.00 ft. to point "A" said point being located on the North and South 1/4 line of said Section 34; thence S. 02° 28' 43" E., along said North and South 1/4 line, 255 ft. more or less to the shoreline of Mystic Lake; thence Southerly and Southwesterly along said shoreline, 635 ft. more or less; thence Southwesterly and Southerly along the waters edge of Mystic Creek, 970 ft. more or less to A point on the East and West 1/4 line of said Section 34; thence S. 86° 35' 49" W., along said line, 300 ft. more or less; thence N. 02° 25' 00" W., 115.00 ft. to point "B" being S. 23° 12' 28" W., 426.64 ft. and S. 60° 10' 35" W., 221.66 ft. and S. 78° 13' 54" W., 184.29 ft. and S. 45° 00' 35" W., 202.26 ft. and S. 53° 51' 33" W., 342.08 ft. and S. 89° 32' 14" W., 115.62 ft. and S. 29° 26' 57" W., 221.95 ft. and S. 15° 03' 45" E., 171.60 ft. and S. 77° 00' 14" W., 150.12 ft. along a traverse line from point "A"; thence N. 02° 25' 00" W., 1212.65 ft.; thence N. 87° 08' 30" E., 347.68 ft.; thence N. 02° 23' 17" W., 1027.36 ft.; thence N. 87° 36' 43" E., 164.99 ft.; thence S. 02° 23' 17" E., 250.00 ft.; thence N. 87° 08' 30" E., 156.57 ft.; thence N. 02° 23' 17" W., 58.99 ft.; thence N. 87° 08' 30" E., 186.79 ft. to the point of beginning, containing 37.16 acres and 24 lots numbered 1 through 24 inclusive AND OUTLOT "C" OF "MYSTIC LAKE HILLS SUBDIVISION".

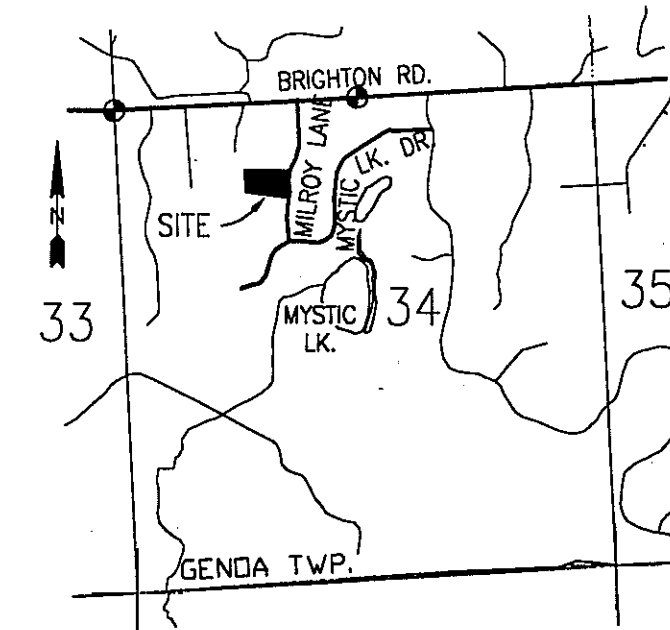

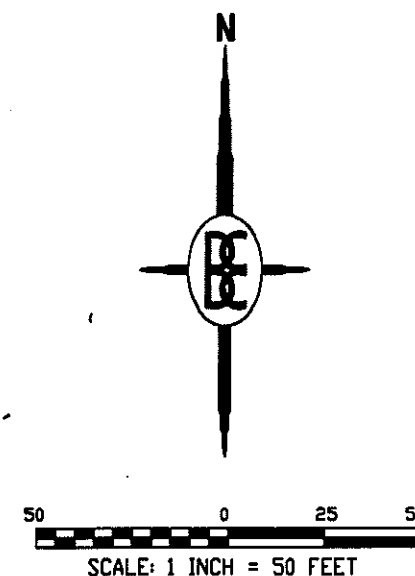

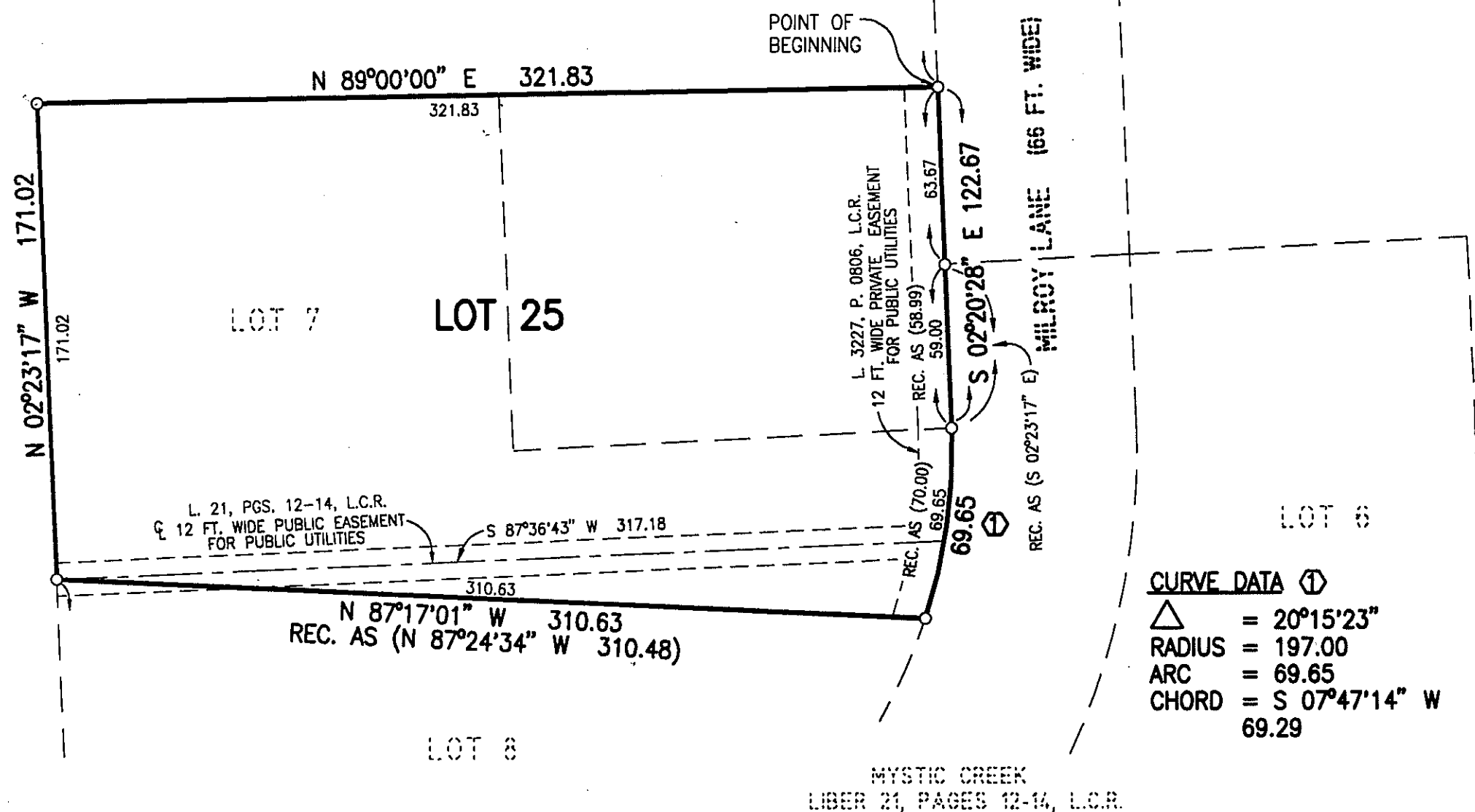
